#### COMMENTS:

Bonanza Creek respectfully requests continued TA status. The Wetco Farms 23-4 was plugged back with CIBP @ 6485' with 2 sacks of cement on 9/24/2018. Form 5A to report TA status of Codell & JSand was submitted 01/08/2019 (Doc # 401807509). This well was SI and plugged back due offset horizontal frac of Bonanza Creek's Wetco Farms A-4 Pad. Well pressure tested to 1200psi, held pressure for 15 minutes, test was good. Bonanza Creek has this well on their 2019 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd. If not already, a Form 6 NOI will be submitted prior to plugging. Once NOI is approved, a Form 42 will be submitted to notify the COGCC of plugging procedures 48 hours in advance of plugging procedures.
