Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

4. TIH with tubing to 1600'. RU cementing company. Mix and pump 40 sxs 15.8#/gal CI G cement down tubing (Pierre coverage from 1600'-1100').
5. Pick up tubing to 867'. Mix and pump 70 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface. TOO H with tubing.
6. Cut surface casing 6' below ground level and weld on cap.
