Comment	<p>Doc. #401136369 states rig release 08/25/2016. COGCC rule 1003.b requires interim reclamation to occur no later than six (6) months on non-cropland.</p> <p>At least two (2) growing seasons have passed, location currently within the third (3rd) growing season since rig release.</p> <p>Weed management appears to be occurring, however vegetation does not appear to be progressing towards 1000 series standards; Vegetation on interim is predominantly undesirable weedy plant species such as Kochia/Salsola sp or bare and exposed soil. Inspector was unable to observe desirable perennial vegetative establishment. Undesirable weedy plant germination prevalent throughout the interim areas. Additional seeding activities may be necessary.</p>
