COMMENTS:

TCO is operting a gas gathering system with a central compressor station, satellite compressor stations and wellhead compressors to pull approximately 7 psi of vacuum at the wells. Attached is a map showing the location of the referenced well. Oxygen monitors are located at each satellite compressor station. If oxygen levels exceed 10ppm at the main gas sales meter, gas sales will be shut off until the levels are returned to 10ppm or less. Actions will be taken to correct the problem. There are no operators other than TCO within 1/2 mile radius.
