Of the remaining 11 wells on the CC 0697-03-07 pad, the SHL and BHL of 7 of the wells are being changed, and 4 wells are being dropped.

- There is no change in the Lot # of the SHL or the BHL in any of the changes (no QQ or 16th lines were crossed because of the changes)
- No changes will be made to the pad; it is sufficient size to accommodate the changes.
- The surface location is fee and Laramie Energy is the surface owner.
- There are no changes to cultural distances, including the new distances to schools; all the distances are over 5280'. The distances to nearest above ground utility are over 3,500'.
- All of Sec 3 is now in CA COC 79101, which was approved after the permits were approved.
- There are no changes to the objective formations.

A 1.9" OD 2.76 ppf J-55 IJ parasite string will be strapped to outside of surface casing with injection mandrel set ~120' above the surface shoe.
