Five discreet confirmation soil samples will be collected (4 wall and 1 base) from the produced water tank excavation. The base and wall sample from the downgradient wall or the wall sample exhibiting the highest PID reading will be analyzed for benzene, toluene, ethylbenzene, total xylenes (BTEX), gasoline range organics (GRO), and diesel range organics (DRO). In addition, one shallow wall sample in the root bearing zone will be collected from the downgradient wall or the wall exhibiting the highest PID reading and analyzed for pH, Electrical Conductivity (EC), and Sodium Absorption Ratio (SAR). See the attached Figure 2.
