Final reclamation was performed during June of 2016. The vegetation appears to be fully established. A follow up inspection will be performed during the growing season. The wattles located at the north side of the location will have to be removed prior to final release. Issues noted in the previous inspection should be evaluated. This includes subsidence along the south side of the location at former cutslope. Also noxious weeds should be controlled.
