Field Inspector Actions:

On 04-23-2019, I was contacted by COGCC staff in reference to some complaint received by the COGCC in reference to Odor. The complaint stated At approximately 9:45 pm she drove on 156th to Huron near the Interchange Pad (facility ID 456747). There was a strong smell of oil. As I arrived home at 156th and Quivas the odor was overpowering. My husband who does not have a very sensitive nose went outside and was overcome by the odor as well. This has an impact on my ability to breathe. I utilized my inhaler after coming into the house. The wind was light out of the east tonight at around 1-2mph according to my weather app. Is it possible that the odor is from the loads of trucks that transport the drill cutting? Could it be from the heated mud as it comes to the surface? Are they utilizing any sort of chiller system on the mud when it comes up? There have been multiple reports to Broomfield today about strong oil odor smells. They dissipate then return.

On 04-24-2019, I attempted to make contact with the complainant who indicated she was smelling oil like odor coming from the Interchange A&B location. I informed her they are using a chiller system. I spoke with Danny Herrera Rig supervisor on site and he informed me they had not been hauling drilling cutting at night, not to say they will not if needed. He also stated that they are using a deodorant to treat the cuttings to reduce odor. I informed her the next time this happens to file another complaint and to contact me and I would come out and perform another onsite inspection to try to find the source of the odor. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I drove to complainant's address and did not smell any unusual odors. I did not smell any unusual odors at the Interchange B pad. Complainant also had concern that the odor might be coming from another well close to her house that was in the P&A process. At time of inspection at the Nordstrom 3-9 Doc #688401996, I did not smell any unusual odors.
