COMMENTS:

As per verbal approval, SandRidge respectfully requests the right to flare this well due to the following circumstances. 1) The closest/most practical pipeline tie-in point is over 100 miles away. 2) It will take several years to construct a pipeline to said tie-in point, once required ROW and permits are obtained. Additionally, construction will cost over \$50 million, and traverse BLM land. 3) An average of ~300-500 mcf/d will be flared for the year, and then will decline in subsequent years. The BTU content of the gas is ~1250-1350 and expected H₂S <1 ppm. 4) SandRidge commenced use of a MRU located just south of the Bighorn CTB in Dec. 2018 and a GTL at the same location in Q1 of 2019, which will both assist in controlling emissions and convert produced gas into a marketable product. SandRidge will continue to comply with Rule 805b (1), Rule 912, monthly reporting of flared volumes (via Form 7), employ CDPHE approved flaring methods (enclosed flares) and permit all enclosed flares/combustors with CDPHE. Lastly, SandRidge has an internal air compliance team, as well as a Colorado-based environmental consultant to assist with monitoring air, combustor testing and environmental compliance.
