Based on the recent Bradenhead test results (Form 17 Doc #401984930, approved 4/8/19), TEP Rocky Mountain LLC (TEP) requests to leave the Bradenhead indefinitely shut-in on the Knight PA 442-4 well. TEP has verified that the stabilized shut-in pressure poses no issues to wellbore or surface casing integrity. TEP will continue to monitor the Bradenhead pressure and notify the COGCC if conditions change.
