COMMENTS:

Bonanza Creek respectfully requests continued TA status. The McFerren 5-2 was plugged back with CIBP @ 6555' with 2 sacks of cement on 2/25/2019. Form 5A to report TA status of Nio/Codell was submitted 03/26/2019 (Doc # 401983218); the well was SI and plugged back due to an MIT test being conducted and will remain TA'd due to uneconomic production. The well is closed to the atmosphere via valve locked out and tagged out at the master valve, and the a "Temporary SI for HZ prep" sign is attached to the master valve. An MIT test was performed 3/18/2019 well pressure tested 500-700psi, held pressure for 15 minutes, test was good. (Form 21 Doc# 401980697). A pressure test was also conducted at the time of the CIBP being set on 2/26/2019, held at 800psi for 10 minutes. Bonanza Creek has this well on their 2020 P&A Schedule, therefore are requesting continued TA status until such time as this well is P&A'd. An annual TA sundry notice will be submitted in 1st Quarter 2020 to update the COGCC on the P&A plans of this well.
