On 1/17/2017 a RBP was set @6829' for offset mitigation/well safety prep, with a 5K wellhead closing well to the atmosphere. This well was TA for safety prep for the fracting of the Great Western Kodak South FD Pad, Location #306149 (7 wells). Due to on-going rig visits and fracs in the area, this well will remain TA until all activity in the area is completed within the next 2 years. A MIT was performed and passed on 8/29/17.
