INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A partially buried produced water vessel (PWV) was removed from the Grant Brothers 10-31 location on January 16, 2019. Groundwater and impacted soil were not encountered in the PWV excavation. A liner was present beneath the PWV at this site. The PWV at this facility has been permanently removed. Soil samples from the excavation were submitted for laboratory analysis, to determine if a release occurred. The general site layout, soil sample location, and PWV excavation dimensions are depicted on the Facility Layout & Sample Locations Map provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On January 16, 2019, following removal of the PWV, soil samples were collected from the sidewalls and base of the excavation. The soil samples were field-screened for volatile organic compounds using a photoionization detector (PID). A soil sample (B01@4) was submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX) and total petroleum hydrocarbons (TPH) – gasoline range organics (GRO) by EPA Method 8260C, TPH diesel and oil range organics (DRO and ORO) by EPA Method 8015, pH and electrical conductivity (EC). Laboratory analytical results for the soil sample (B01@4) indicate that BTEX, TPH, pH, and EC concentrations were in full compliance with COGCC Table 910-1 allowable levels. The soil sample analytical results are summarized in Table 1, and the laboratory analytical report is attached.

Laboratory results indicate that the soil sample was in full compliance with COGCC Table 910-1 allowable levels, therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

Laboratory results indicate that soil sample concentrations were in compliance with COGCC allowable levels. Groundwater was not encountered in the PVV excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. This Supplemental Form 27 has been prepared to request a No Further Action (NFA) determination for this site.
