New compressors were recently installed at this location by our Midstream partner, which are at this time fully operational. While our midstream partner is in the process of constructing and tying in a centralized production facility, there may be concerns of the compressor going down at unknown times/intervals. If this were to occur, gas from the producing wells on this pad would need to be flared, as the line pressure would be too high to send gas to sales. The centralized production facility is scheduled to be completed by August 2019. This sundry is being submitted to serve as a notice per the request of Stuart Ellsworth should flaring have to occur under upset conditions during this time.
