During this inspection the following compliance issues were identified as resolved:

- 1) Containers without labels were removed from location.
- 2) Tank label & cover added.
- 3) Well head sign reinstalled.
- 4) Oily waste around pump jack removed.
- 5) Oily waste around tank removed.
- 6) Uncapped riser removed.
