On Friday 05/03/2019 at approximately 13:30 I, Inspector Emily Waldron, conducted a field inspection at Sandridge Exploration and Production LLC Rabbit Ears 0681 23, Location ID 449274, in Jackson County, Colorado. Inspection was stormwater focused and in direct response to observation of vehicle tracking onto Colorado State Highway 14. During this inspection the following possible compliance issues were observed:
Access road is washed out from recent heavy precipitation events. No BMPs or operator response observed. Vehicle tracking occurring off of location and onto Colorado State Highway 14 for approximately 0.6 miles north of location. See photos 1-10.
Maintain vehicle tracking BMPs on the oil and gas location to comply with rule 1002.f.(2)F. If material is tracked onto County or public roads, contact the appropriate authority by 5/6/2019. Install or repair required BMPs per Rule 1002.f by 5/8/2019.
I spoke with Aaron Cook of Sandridge by phone on 05/03/2019 and continued vehicle tracking was discussed.
A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report 689802625.
