Comments Noble respectfully submits this application for a permit to drill, which is a part of a three well pad producing to pad BB-05-28.

Nearest well in the same formation is the Wells Ranch State BB05-690, the distance was calculated in 3D.

The nearest well belonging to another operator is State 6525 31-32, 05-123-20368, PA Operated by PDC Energy Inc distance was calculated in 3D using anti-collision report. 317.S consent is not required.

Noble Energy shall isolate both the Fox Hills and Upper Pierre Aquifers with surface casing from hydrocarbon bearing zones and exposures to oil based drilling fluid. Noble Energy also agrees to not expose the Upper Pierre Aquifer to oil based mud.
