Appears the Operator has performed final reclamation activities; however, location will remain in-process as it does not meet Rule 1004 standards. Cheatgrass was observed in high densities throughout the well location which is not reflective of reference area vegetation. Reference area vegetation mainly consists of Sand dropseed. Refer to the attached inspection photos.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct follow-up inspections prior to receiving said notice to ensure compliance with Rule 1004.
