Core samples were obtained using a skid steer with auger attachment, in an attempt to obtain proper documentation for pit closure. One sample was taken because sensory observations during sampling concluded that an exceedance was probable and soil samples most likely would not meet Table 910 -1 requirements. Analysis (attached) shows that the sample did not meet requirements for total TPH. Background (offsite) samples were not collected, as it's been previously established that high levels of arsenic are naturally occurring in the area. See attachments for previously tested high levels of arsenic in the Powder Wash area. Please see attachments for GPS coordinates of sample and soil observations made during the sampling process.
