Core samples were obtained using a skid steer with an auger attachment, in an attempt to obtain proper documentation for pit closure. One sample was taken, as sensory observations during sampling indicated that an exceedance was probable and the sample most likely wouldn't meet Table 910-1 requirements. Analysis (attached) shows that the sample did not meet requirements for total TPH. Background (offsite) samples were not collected, as it's been previously established that high levels of arsenic are naturally occurring in the area. See attachments for previously tested high levels of arsenic in the Powder Wash area. Please see the attachments for GPS coordinates of sample and soil observations made during sampling.
