#### COMMENTS:

The bradenhead buildup pressure on this well is over the 50 psi threshold. GWOG has obtained a bradenhead gas and production gas sample for isotopic analysis. We would like to plumb the bradenhead to a temporary tank and keep the pressure below 50 psi for a 5 week period, in hopes that it dissipates.  
After the 5 week blowdown period we will conduct a buildup test to see if the pressure returns to the threshold.  
If pressure does not build back to the actionable threshold, we would like to continue with annual reporting via bulk submissions.  
If pressure returns to the actionable threshold, we will set a permanent 40-50 barrel abatement tank on the well pad to which we will plumb the bradenhead to keep the pressure bled off.
