Plug set 6700' for offset Wake East XOG frac. The two sacks of cement placed on top of the CIBP technically designates this formation as AB, however, the TA distinction was chosen because PDC intended to return this well to production upon the conclusion of the frac. Tubing was pulled, plug and casing were pressure tested up to 2000 psi for 15 mins and a 5K wellhead was installed.
