On 05-17-2019, I was contacted by COGCC staff about a complaint received by the COGCC in reference to Odor. The complainant stated the issues were occurring outside of his home, from the Interchange A&B pad.

On 05-19-2019, I attempted to make contact with the complainant who indicated on his complaint form that on 5-16-19 at approximately 6:45 he smelled on odor that resembles oil. He was in his house with windows opened when he first smelled it. He had to close the windows of his house. At time of inspection on 05-17-19 at approximately 6:40PM, I did not smell any unusual odors. I drove around complainant's neighborhood and Interchange B drilling pad were I performed a site inspection of the drilling operations. At time of inspection, it was raining and there was a drop in temperature. I spoke with Broomfield inspectors and they are aware of complaint.
