Ensure that 2' of freeboard is maintained at all times.</p> <p>The netting on the lower pit has several holes present. A duck was observed swimming in the lower pit during this inspection. SG personnel were notified and the netting was pulled back in the SW corner in an attempt to free the duck.</p> <p>A water hauler was transferring water from the lower pit to be delivered to the injection well.</p>	hughesjo	05/20/2019
