INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A subsurface assessment will be conducted to determine if petroleum hydrocarbon impacts to the subsurface media exist from a former earthen pit at the Brattain L - 63N66W #12NWSE location.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Two soil borings will be advanced to approximately 5 ft below ground surface at the former pit location. The borings will be continuously field screened using a photoionization detector (PID). A soil sample will be collected from each boring from the interval with the highest PID reading. In the absence of any elevated PID reading, a soil sample will be collected from the total depth of each boring. The soil samples will be submitted for total petroleum hydrocarbons (TPH), benzene, toluene, ethylbenzene, and total xylenes (BTEX), pH, specific conductivity (EC), and total metals analysis. The analytical results will be compared to Colorado Oil and Gas Conservation Commission (COGCC) Table 910-1 and the United States Geological Survey maximum background arsenic concentration of 7.72 mg/kg for Valent-Julesburg soil. If EC exceeds the COGCC allowable level, the sample will be further analyzed for sodium adsorption ratio. The analytical results will be provided in a supplemental Form 27.
