#### Proposed Procedure:

1. MIRU pulling unit. Pull 1 1/2" tubing.
2. RU wireline company.
3. TIH with CIBP. Set BP at 6544'. Top with 2 sxs 15.8#/gal CI G cmt.
4. TIH with casing cutter. Cut 3 1/2" casing at 1600'. Pull cut casing.
5. TIH with tubing to 1715'. Mix and pump 255 sxs 15.8#/gal CI G cement with 2% CaCl down tubing (Pierre coverage from 1715'-1300').
6. Pickup tubing to 517'. Mix and pump 335 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface. TOOH with tubing.
7. Cut surface casing 6' below ground level and weld on cap.
