## SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

The source area will be removed through excavation of impacted soil. Inaccessible impacted soil above COGCC Table 910-1 standards will be left in place and addressed in situ. A groundwater amendment will be applied to the base of the excavation to aid in source groundwater remediation. Grab confirmation soil samples will be collected above the phreatic zone by Eagle Environmental and delivered to Origins Laboratory under proper chain of custody procedures for analysis of TPH-DRO, TPH-GRO, BTEX, and Naphthalene by EPA Methods 8015 and 8260C.

## REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Further remediation will be discussed in a supplemental form 27. An AS/SVE pilot test was conducted in the vicinity of the large tree on the west side of the site and the results have excluded this as a viable remedial technology. Further assessment activities were completed between February 15, 2019 and February 20, 2019. Remediation options are currently being evaluated. Remediation of source material will commence after July 15, 2019 due to an active Red Tail Hawk nest 160 feet north of the location. This is within the 0.33 mile avoidance buffer per CPW Guidance. An update will be submitted on a supplemental form 27 prior to source removal.
