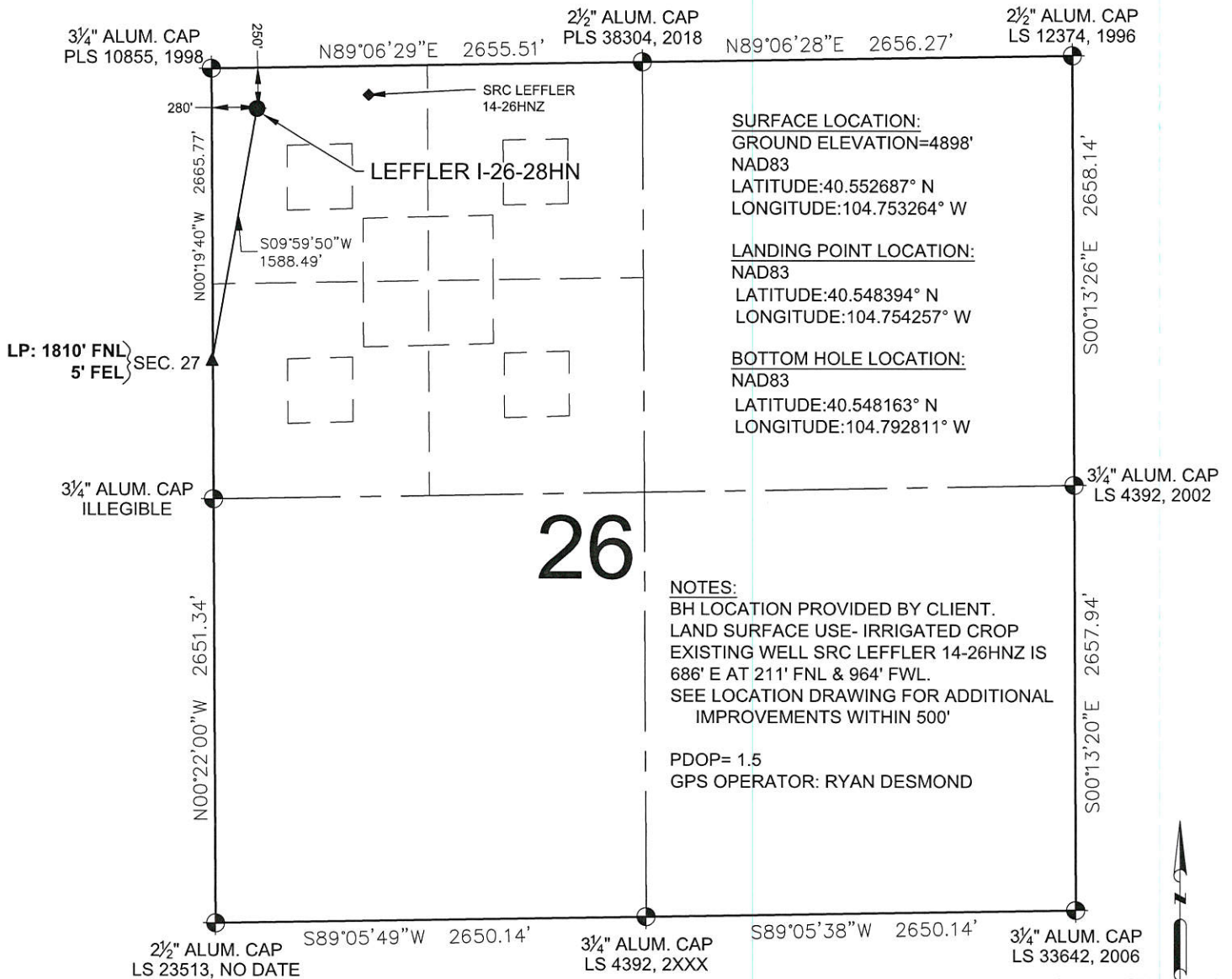


# LEFFLER I-26-28HN WELL LOCATION EXHIBIT
