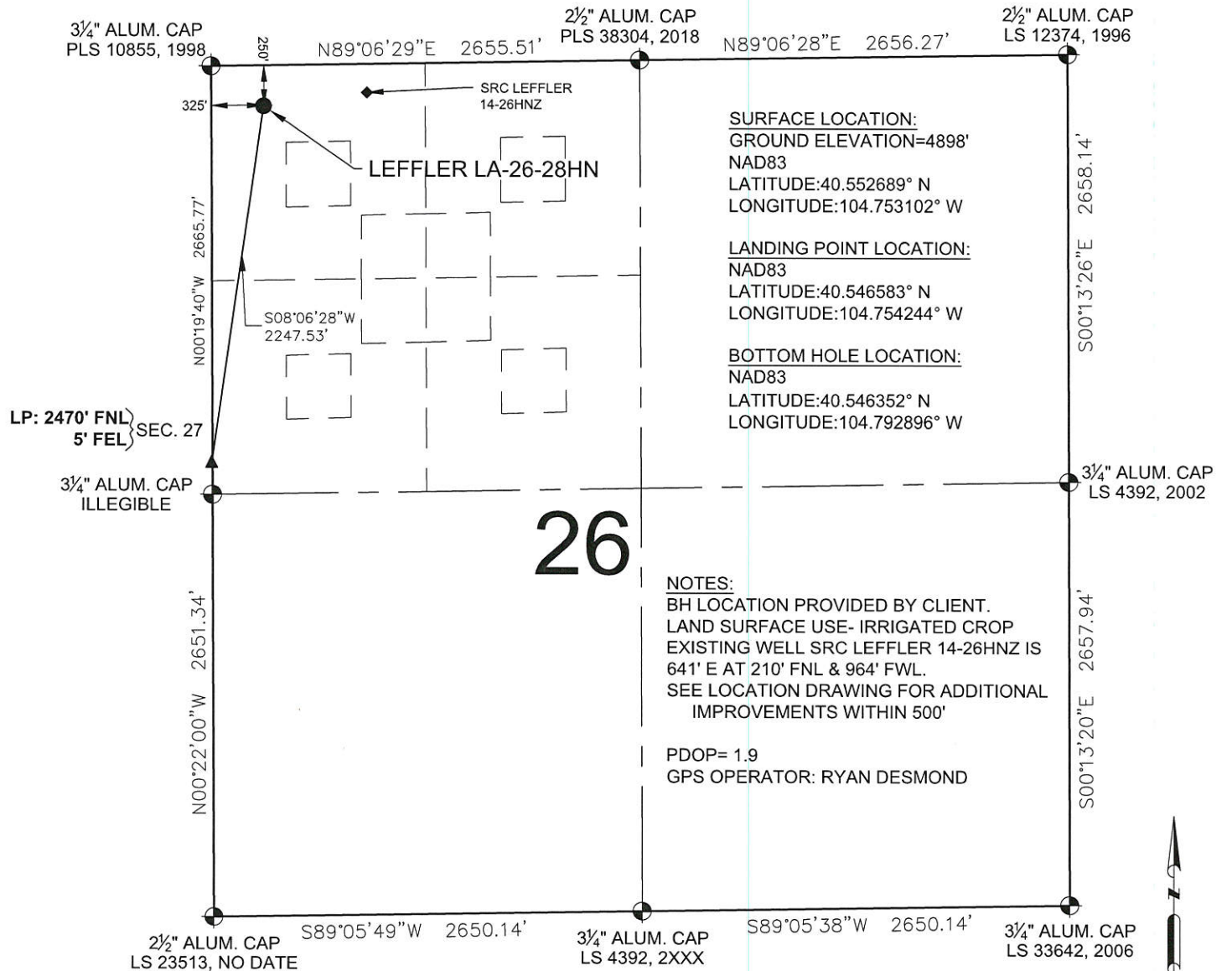


# LEFFLER LA-26-28HN WELL LOCATION EXHIBIT
