2. RU wireline company.

3. TIH with CIBP. Set BP at 6575'. Top with 2 sxs 15.8#/gal CI G cmt.

4. Run CBL from 6400' - surface in order to verify/identify cement interval and TOC.

5. TIH with casing cutter. Cut 3 1/2" casing at 1700'. Pull cut casing.

6. TIH with tubing to 1815'. Mix and pump 250 sxs 15.8#/gal CI G cement with 2% CaCl down tubing (Pierre coverage from 1815'-1400').

7. Pickup tubing to 517'. Mix and pump 335 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface. TOOH with tubing.

8. Cut surface casing 6' below ground level and weld on cap.
