During this inspection the following possible compliance issues were observed:</p> <ol style="list-style-type: none"> 1. Stained soil left side of east separator. SECURELY FASTEN ALL VALVES, PIPES, AND FITTINGS TO ENSURE GOOD MECHANICAL CONDITION, INSPECT AT REGULAR INTERVALS AND MAINTAIN IN GOOD MECHANICAL CONDITIONS PER RULE 605.D. (Corrective Action Date: June 23, 2019) See attached photo #2. 2. Trash inside gas meter house. COMPLY WITH RULE 603.F. (corrective Action Date: June 2, 2019) See attached photo #3. 3. Unused used equipment inside gas meter house, right side of middle separator, and two disconnected seperators. COMPLY WITH RULE 603.F.
