While there, I observed Production.  
During this inspection the following possible compliance issues were observed:  
2 Non reportable spills - stained soil at pump jack motor and wellhead, photos 2 and 3. Securely fasten all valves, pipes, and fittings to ensure good mechanical condition, inspect at regular intervals and maintain in good mechanical condition per Rule 605.d and comply with Rule 603.f, by 6/21/2019.  
A concrete base stored on location perimeter, photo 4. Comply with Rule 603.f, by 6/21/2019.  
A pit in the tank battery with no permit on file, photo 5. Submit an eForm 15 Pit Report to update COGCC records with current information to comply with rule 903.a.  
Produced volumes are required to be reported accurately from the wellhead meter every month, and the form 7 reporting does not reflect that accurate measurement. Submit required Form 7(s) to COGCC per rule 309 by 6/21/2019.
