Comment: SG has been working diligently since 4/10/2019 to reduce fluids as quickly as possible. The week of 4/10/19 had a big snow-melt event and in a matter of 2 days the extra freeboard did as it was intended to do and captured that snow-melt. There was no risk of overflow. In addition, the month of May has been a higher than average precipitation month so the efforts to reduce freeboard has taken longer. More trucks have been added to haul water out of the pits. Another suction and discharge line has been added at the injection well to load and unload faster. Again, SG will continue to work diligently to get back to the 2' freeboard, however the 5/21 due date is not attainable based on the weather.
