On May 15, 2019, COGCC Environmental Staff (John Heil and Steven Arauza) conducted an environmental field inspection of FOUNDATION ENERGY MANAGEMENT LLC (Foundation, operator# 10112) Location ID 322413 to examine pit ID 119476. Weather was sunny and temperatures about 65 degrees Fahrenheit.

The purpose of the inspection was to follow up on Remediation Project# 13414, to close pit ID# 119476 (Doc# 401962566).

There is a partly buried 95 bbl produced water tank on location (south of pit ID 119476) that contains hydrocarbons (see photos). Operator has until 6/23/2019 to submit a complete eForm 15 to the COGCC (Doc# 401962566).
