

- 12-30-52 Spudded
- 12-31-52 Ran and cemented 8 5/8" casing at 596 feet with 300 sacks.
- 1-7-53 Drill stem test No. 1 4917-32 open 2 hrs. Instant good blow. Gas in 10 minutes at 92 MCFD. Recovered 100' oil and gas cut mud. ISIP failed, IFP 0. FFP 0. SI 30 min 1160. Hydro 2550. Ran Schlumberger.
- 1-9-53 Cemented 5 1/2" casing at 4918 feet with 100 sacks.
- 1-13-53 Loaded hole with 30 barrels of oil, Perforated 4830-34 with 16-28 gm jets. Ran tubing.
- 11-16-53 Ran tubing with Baker RT-8 to stratafrac.
- 1-19-53 Stratafraced formation.
- 1-22-53 Flowed 120 barrels of oil, no water, 24 hrs. Thru 16/64" choke from perforation opposite 'Muddy' COMPLETE
