TEP Rocky Mountain LLC requests permission to repair the TR 344-22-597 per the following procedure. Operations are scheduled to begin Monday, June 3, 2019. Wellbore diagrams are attached:

1. MIRU SPN 20
2. ND frac tree NU BOP's test bops to 400/4500 psi.
3. Make up 3.875" string mill assembly, RIH to 9300' (approx. 1200' below hole) and address any bobbles or tight spots.
4. POOH with string mill.
5. Make up 4 1/2" crest packer, RIH and isolate hole to within 10' above and below while testing to 4500 psi @ surface with rig pump, leave packer set 10' above hole.
6. MIRU reliance wireline, RIH with gamma logging tool and correlate tbg tally to casing log.
7. RDMO Reliance wireline
8. If correlation goes well proceed to step 11. If not comfortable go to step 9.
9. RIH with 4 1/2" composite bride plug and set 45' below hole.
10. RIH and set tbg 10' above hole
11. Land tbg on Hanger
12. Wait on 60' Enventure patch to arrive
13. Follow Enventure setting procedure, set patch between 8,246' - 8,306'
14. ND BOP's, NU Frac tree and test to proposed frac PSI
15. RDMO MWS 20
