 4. TIH with tubing to 1700'. RU cementing company. Mix and pump 135 sxs 15.8#/gal CI G cement down tubing (Pierre coverage from 1700'-1200'). Cement should circulate to surface. TOOH with tubing.
 5. Cut surface casing 6' below ground level and weld on cap.
