#### COMMENTS:

Bonanza Creek respectfully requests continued TA status. The Antelope P-19 was plugged back with a CIBP @ 6,624' and 2 sacks of cement on 2/3/2019. Form 5A to report TA status of Nio/Codell was submitted 3/3/2019 (Doc # 401943262); the well was SI and plugged back due to offset HZ frac of Bonanza Creek's Antelope T-19 Pad. The well is closed to the atmosphere locked out and tagged out at the master valve, and the a "Temporary SI for HZ prep" sign is attached to the master valve. Well pressure tested on 2/2/2019 to 1000psi, held pressure for 10 minutes, test was good. This well is being evaluated as a potential gas injection well for a future Bonanza Creek gas injection project, therefore are requesting continued TA status until such time. An annual TA sundry will be submitted in 2020 to update the COGCC of this well's status.
