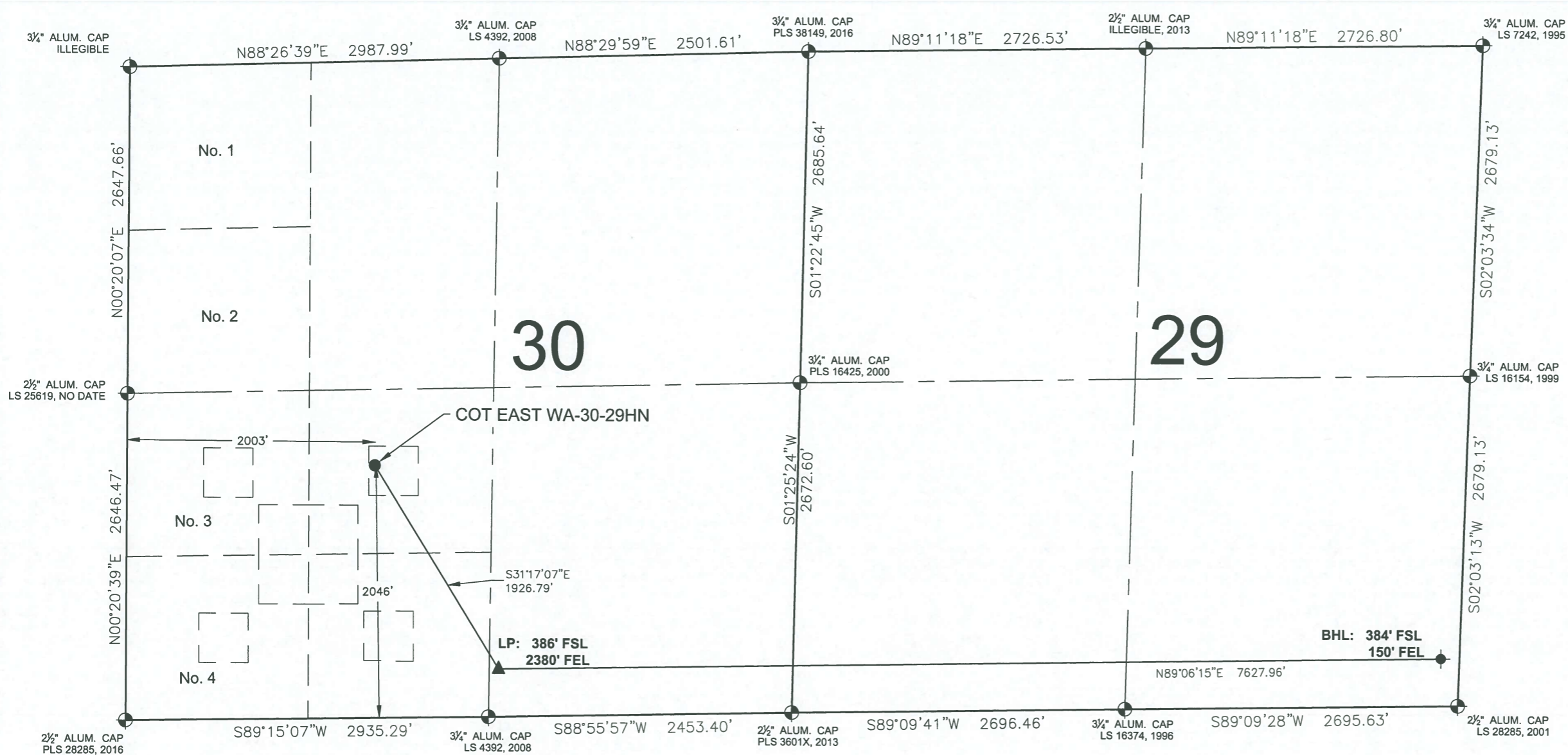


COT EAST WA-30-29HN WELL LOCATION EXHIBIT

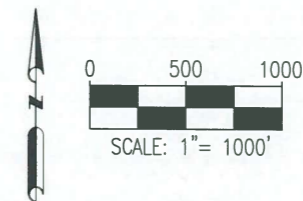
