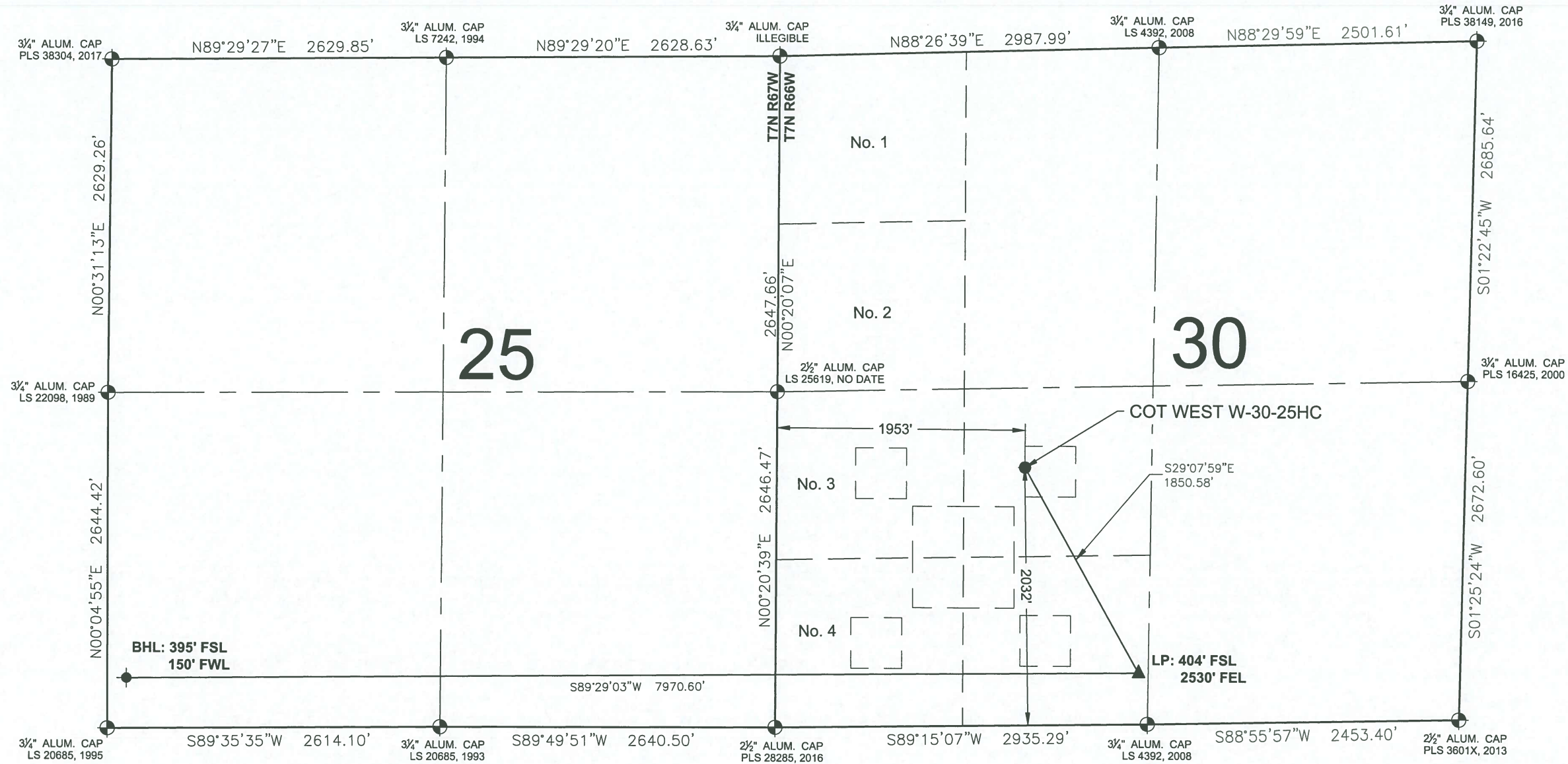


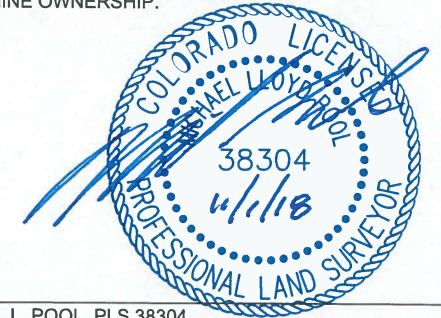
## COT WEST W-30-25HC WELL LOCATION EXHIBIT

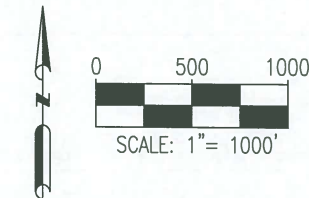
