Comment: The culverts have been cleaned out and repaired. Rock rip/rap has been added for inlet outlet protection. There was water in one culvert that was not draining well. Sediment may need to be further cleaned out. Another culvert had sediment accumulation already occurring. Checkdamns may be needed up gradient. Rock rip/rap was placed at the erosion channels at the location and at culvert outlet.. There was still an erosion channel forming at the east side of the location which will need to be repaired. Berm has been repaired around the stockpile. See Attached Photos
