 On 06-03-2019, I Field Inspector, Randy Silver was issued a complaint received by COGCC staff in reference to Odor. The complainant Barbara Binder 15583 Quivas St Broomfield CO stated the issues were occurring outside of her home, from the Interchange A&B pad.
 On 06-03-2019, I attempted to make contact with the complainant who I spoke to on 6-03-19 at approx... 9:15AM in front of her house. She indicated that on 06-02-19-19 she experienced a heavy odor of oil. Irritating to the throat and eyes. Strong enough that it has permeated the inside of her house since she has the windows open.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any unusual odors While speaking with Barbara Binder outside her house. I spoke with Broomfield inspectors and they are aware of complaint and have responded to it.
 At time of inspection, I spoke with Extraction drilling supervisor he stated at approx... time of complaint they made a connection and normal drilling, no unusual activity was taking place.
