 Field Inspector Actions:  
 On 06-04-2019, I Field Inspector, Randy Silver was issued a complaint received by COGCC staff in reference to Odor. The complainant Kathy Swan Bogard 15543 Quivas st Broomfield CO stated the issues were occurring outside of her home, from the Interchange A&B pad.  
 On 06-04-2019, I attempted to make contact with the complainant who indicated that on 06-03-19 at 7:30AM she woke up coughing. She opened the front door of her house, which faces towards Interchange B pad and noticed the strong smell of oil.  
 At approx.... 8:00AM on 6-3-19 I performed a complete site inspection of the oil and gas location and associated wells in the area along with complainant's neighborhood. At time of inspection, I did not smell any unusual odors. I was in complainant's neighborhood until approx. 9:30 AM. I spoke with Broomfield inspectors and they are aware of complaint and have responded to it.  
 At time of inspection, I spoke with Extraction drilling supervisor he stated at time of complaint they were drilling and no unusual activity was taking place.
