Comment:

Inspection #668700451 passed reclamation for the location, however, based on inspector comments it is clear that location did not meet reclamation standards and should not have been passed.

This location does not meet reclamation requirements; vegetation on location has not achieved a uniform vegetative cover reflective to that of the reference area. What appear to be ~15 monitoring wells have been left on the location, as well as the perimeter fence. Access road has not been reclaimed. The section of access road that crosses a drainage has not been recontoured/regraded to that of the adjacent lands, stormwater erosion and sediment transport within drainage evident.

Corrective Action:

Perform reclamation in accordance with COGCC 1000 series rules and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 7/5/2019
