

CORRECTIVE ASSIGNMENT AND BILL OF SALE

This Corrective Assignment and Bill of Sale (this "Corrective Assignment") is made and entered into this 6th day of June, 2019, but is made effective as of June 1, 2017 ("Effective Date"), and is by and between Ward Petroleum Corporation, an Oklahoma corporation ("Ward"), and HighPoint Operating Corporation ("HighPoint"), as successor-in-interest to Fifth Creek Energy Operating Company, LLC ("Fifth Creek").

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Ward, WEP Operating Co, LLC, Apple Rock, Inc., GCT, Inc., Jordan Revielle, and Catamount Resources, LLC, as assignors, and Fifth Creek, as assignee, entered into an Assignment and Bill of Sale effective as of the Effective Date (the "Original Assignment") assigning to Fifth Creek certain oil and gas interests, with such Original Assignment recorded in the real property records in Weld County, Colorado at Reception No. 4319526;

WHEREAS, HighPoint is successor to Fifth Creek's interests from the Original Assignment;

WHEREAS, Ward intended to convey to Fifth Creek certain oil and gas facilities owned by Ward and described on Exhibit A attached hereto and made a part hereof (the "Facilities"), but such interests were inadvertently left off of the Original Assignment; and

WHEREAS, in order to correct the Original Assignment and convey the Facilities to HighPoint, the parties file this Corrective Assignment.

NOW, THEREFORE, for and in consideration of mutual benefit to the parties to this instrument and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the parties to this Corrective Assignment do hereby amend the Original Assignment by adding to the definition of the "Assets" conveyed from assignors to assignee the Facilities described on Exhibit A attached hereto, and Ward does hereby forever GRANT, BARGAIN, SELL, CONVEY, ASSIGN, TRANSFER, SET OVER AND DELIVER unto HighPoint all of Ward's right, title and interest in and to the Facilities, effective as of the Effective Date.
