On Wednesday 05/29/2019 at approximately 13:00, I, Inspector Emily Waldron, conducted a field inspection at Sandridge Exploration & Production LLC Peterson Ridge 1-20H at 05-057-06515 in Jackson County Colorado.

While there, I performed a follow up inspection to vehicle tracking issues observed in inspection document number 689802622. Vehicle tracking corrective actions have not been resolved.

During this inspection the following possible compliance issues were observed:

Tracking off location occurring onto highway 40 in both directions. No tracking BMPs observed. See photos 1-4. Maintain vehicle tracking BMPs on the oil and gas location to comply with rule 1002.f.(2)F. If material is tracked onto County or public roads, contact the appropriate authority by 5/8/2019.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection 689802773 report.
