INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to support remedial investigation of observed historical soil staining associated with Spill/Release Point ID: 465089 related to a former well pad operated by Texas Tea. The initial investigation will be conducted using Geoprobe drilling equipment. Approximately six boreholes will be drilled to preliminarily delineate the potential contamination: one at the approximate suspected spill source, one upgradient of the suspected spill source, and four downgradient of the suspected spill source. Field screening of collected soils will be conducted during drilling and samples will be collected for laboratory analysis. Soil samples and groundwater, if present, will be collected and analyzed for BTEX and TPH to assure compliance with COGCC Table 910-1 allowable limits and to delineate the potential extent of impacts from the release. Additional delineation borings may be installed depending upon field screening results and site conditions. No Crestone Peak Resources production equipment is currently present on site; therefore, the release is confirmed to be historic in nature.

In support of remedial investigation, approximately six boreholes will be drilled to delineate the extent of potential impacts: one at the suspected spill source, one upgradient of the suspected spill source, and four downgradient of the suspected spill source. One or more discrete grab soil samples will be collected from each borehole location and submitted for laboratory analysis of organic constituents (TPH and BTEX).
