**COMMENTS:**

We are unable to pass through an obstruction at 5,060' on the reference well. We are planning to run production casing to 5,036' and cement to ~2000' in hopes of converting this well into a G Sand producer.

Well: CC 0697-04-07E

Field: Cascade Creek

Surface Casing: 9-5/8" 36# J-55 set @ 2577' MD / 2575' TVD

Surface Cement: Pumped 878sx of 12.3ppg lead and 252sx of 12.8ppg tail. Pumped an additional 400sx down parted parasite line.

Performed Top Job of 725sx (25bbls) of 15.6ppg Neat G through 3 different top jobs, and got cement to surface.

Original Well TD: 9,481' MD / 9,463' TVD (Rollins)

Wellbore Obstruction: 5,060' MD / ,5048' TVD

Prog G Sand: 4,780' MD / 4,768' TVD

**Description:**

Parasite string parted while running surface casing and decision was made to drill ahead in production section without one.

Production hole drilled without issue to planned TD. Production casing was ran to 5200' at which point it was unable to be ran any further. Wellbore began caving in and casing was pulled, leaving two centralizers in the well. Multiple cleanout runs were attempted, but were unsuccessful in getting past an obstruction at 5,060'.

**Plan Forward:**

Run 4-1/2" production casing to 5,036' and cement from TD to ~2,000' with 12.5ppg, 1.946ft3/ft, Type II/IV cement (same as planned lead cement).
