 On 06-17-2019, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to Odor. The complainant Barbara Binder 15583 Quivas st Broomfield CO stated the issues were occurring outside of her home, from the Interchange A&B pad.  
 On 06-17-2019, I attempted to make contact with the complainant who indicated that on 6-15-19 she smelled very strong odor of oil present. I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I did not smell any unusual odors.  
 At time of inspection, I spoke with Extraction drilling supervisor he stated at time of complaint they were drilling and no unusual activity was taking place.
