Request an Exemption from Rule 325c.1 for the Lyons, L. Satanka, Wolfcamp, Amazon, Council Grove, Admire, Virgil, Missouri, Fountain, Des Moines & Atoka Formations for the Roy SWD 5 (API 05-123-49501) well due to its proximity to the South Weld SWD 1 (API 05-123-47682) and its tested high formation water TDS analysis results. The South Weld SWD 1 is a vertical well and the Roy SWD 5 is a directional well with the injection formations separated by approximately 7773'. The South Weld SWD 1 water sample results are attached with all TDS values well above 10,000mg/L. A TDS Cross Section diagram is attached showing the details of the TDS values in the C2C (API 05-123-42698) and correlated to the same formations of the C5 (API 05-123-40645) with the South Weld SWD 1 and Roy SWD 1 being in between.
